## Monday August 28th

#### Did you know?


There is new legislation in place to protect YOU if you call 911 in case of an overdose. The new Good Samaritan Drug Overdose Act means that you won't be charged with drug possession if you call for help. It also protects you if you are in breach of parole, pre-trial release, a probation order or a conditional sentence. It applies to everyone seeking emergency help during an overdose, including the person overdosing. Getting emergency help can save a person's life.

### Tuesday August 29th

Overdose death IS preventable! Drug policy and prohibition contribute to high overdose rates and other human rights issues. Advocate today for the decriminalization of drug use, and ending the war against drugs and the people who use them!



# Wednesday August 30th

Naloxone saves lives! It is a safe and effective drug that temporarily reverses the effects of an opioid overdose. If you're at risk for an overdose, you can get a free take-home-naloxone kit and get overdose recognition and response training at over 40 distribution sites across

## **Thursday August 31**

Every community has been impacted by overdose, from deaths to permanent injury. Overdose doesn't discriminate - people from all walks of life are affected, from first time to experienced users, from those who use casually and infrequently to people who use daily.

We have the power to prevent overdose harms, through evidence based-harm reduction initiatives like naloxone programs and supervised consumption sites, and through changing legislation that stigmatizes and criminalizes people who use drugs, isolating them and pushing them to unregulated drug markets where you can never know exactly what you're getting.

Speak up now, act with courage, demand change. We all love someone who uses drugs.

Some Canada Specific Ideas Include:

#### Publicizing the Good Samaritan Law

This could be as simple as printing out and distributing the leaflets attached to this email! Or talking about the legislation at one of your regular groups or activities.

Some ideas include

- 1. Connecting with RCMP/local police services for a lunch and learn or training on the legislation
- 2. Doing training for peers/community that includes Good Samaritan Legislation
- 3. Outreach style handing out of postcard about Good Samaritan Legislation

Some background on the Good Samaritan Legislation:

The Good Samaritan Drug Overdose Act provides some legal protection for individuals who seek emergency help during an overdose. The act became law on May 4, 2017.

The act can protect you if you are in breach of the following conditions under section 4 (1) of the Controlled Drugs and Substances Act:

- parole
- pre-trial release
- probation orders
- simple possession

#### conditional sentences

The Good Samaritan Drug Overdose Act applies to anyone seeking emergency support during an overdose, including the person experiencing an overdose. The act protects those who either stay or leave from the overdose scene before help arrives.

The act does not provide legal protection against more serious offences, such as:

- outstanding warrants
- production and trafficking of controlled substances
- all other crimes not outlined within the act

#### Organizing a Naloxone Distribution Event

Partner with the a health region or pharmacy in your region to host a naloxone training and distribute kits to the people that need them most! A list of distribution sites for the Manitoba take home naloxone program can be found here:

#### Background on Naloxone:

Naloxone is an antidote to opioid overdose. During an overdose, it can be injected into a muscle. This can temporarily reverse the effects of opioid drugs. Naloxone has no effect on drugs that are not opioids.

People who are at risk of opioid overdose may access free take-home-naloxone kits and get overdose recognition and response at participating distribution sites.

# Hosting an Overdose Intervention Training in your Community

If you can't distribute Naloxone you can still save lives by sharing information about what to do in case of overdose.
